# DVG WARRANTY INFORMATION

## WHAT DOES THIS WARRANTY COVER?

This limited warranty covers defects in materials and workmanship of the DVG pistol manufactured and sold by SCCY (the "product") for the Warranty Period as defined below.

## WHAT DOES THIS WARRANTY NOT COVER?

This limited warranty does not cover any damage due to: (a) careless handling, (b) unauthorized adjustments, (c) modifications, (d) improper ammunition, (e) corrosion, (f) neglect, (g) abuse, (h) transportation; (i) improper storage; (j) improper use; (k) failure to follow the product instructions or to perform any preventive maintenance; (l) normal wear and tear; (m) unreasonable use, or (n) external causes such as accidents or other actions or events beyond our reasonable control or the reasonable use of the product. You will void this limited warranty by modifying the product or by adding accessories, even if such accessories or modifications are sold by SCCY, including without limitation grip modules purchased from SCCY. If your SCCY product purchase includes accessories which were not manufactured by SCCY (for example, sights and grips), such accessories are expressly excluded from SCCY's limited warranty. If the manufacturer of the accessory offers a warranty, such warranty will be your sole remedy as to claims regarding the accessory. To the extent reasonably possible, SCCY will provide you with a copy of or a link to the accessory warranty on SCCY's website. If you have any issues or problems with the accessory, please adhere to that manufacturer's warranty requirements to preserve any and all rights.

## WHAT IS THE PERIOD OF COVERAGE?

This limited warranty starts on the date of original purchase of the product and will terminate upon the date on which the first denial of a warranty claim is made (the "Warranty Period"). We may change the availability of this limited warranty at our discretion, but any changes will not be retroactive.

## WHAT ARE YOUR REMEDIES UNDER THIS WARRANTY?

With respect to any defective and covered product during the Warranty Period, we will, in our sole discretion, either: (a) repair such product (or the defective part) free of charge or (b) replace such product (or the defective part) free of charge. The shipping and handling fees for you to send the product to us shall be borne by you. We will pay for shipping and handling fees to return the repaired or replacement product to you.

## HOW DO YOU OBTAIN WARRANTY SERVICE?

To obtain warranty service, you must either call 866-729-7599 or email [SERVICE@SCCY.COM](mailto:SERVICE@SCCY.COM) and speak with the service department before shipping the product during the Warranty Period to obtain a Return Merchandise Authorization ("RMA") number. No warranty service will be provided without a RMA number. The risk of loss and shipping and handling costs to deliver the product to SCCY shall be borne by you. The risk of loss and shipping and handling costs to deliver the product back to you shall be borne by SCCY.

## LIMITATION OF LIABILITY

THE REMEDIES DESCRIBED ABOVE ARE YOUR SOLE AND EXCLUSIVE REMEDIES AND OUR ENTIRE LIABILITY FOR ANY BREACH OF THIS LIMITED WARRANTY.
